

# Integra First Federal Credit Union Luck of the Loan Giveaway Official Rules

**THE ODDS OF WINNING DEPEND UPON THE NUMBER OF ELIGIBLE ENTRIES RECEIVED DURING THE SWEEPSTAKES PERIOD.**

Integra First Federal Credit Union's ICU Day Giveaway (**the "Sweepstakes"**) starts on Monday, March 3, 2025, at 8 a.m. ("CT") and ends on Wednesday, April 30, 2025, at 11:59 p.m. Central Time ("CT") (**"Sweepstakes Period"**) or when the online loan applications reach 100 entries.

**ELIGIBILITY:** Open only to legal residents of the fifty (50) United States and the District of Columbia, 18 years of age or older at time of entry. Void where prohibited. Employees (and their immediate families (parent, child, spouse or sibling and their respective spouses, regardless of where they reside) and those living in their same households, whether or not related) of Integra First Federal Credit Union (**"SPONSOR"**), and their respective parents, affiliates, subsidiaries, vendors, and advertising and promotion agencies are not eligible to enter or win. All online entries must be received by 11:59 p.m. ("CT") on Wednesday, April 30, 2025, to be eligible. Limit one (1) entry per person for the duration of the Entry Period. Entries generated by script, macro or other automated means or means which subvert the entry process will be void. No giveaway pages are allowed to enter the giveaway. All entries become the property of Sponsor and will not be acknowledged or returned.

**Drawing:** Potential winners will be selected in a random drawing held on or about Thursday, May 1, from all eligible entries received by Integra First Federal Credit Union (**"SPONSOR"**). Odds of winning depend on the number of eligible entries received.

**WINNER NOTIFICATION:** Potential winners will be notified on or about Thursday, May 1, by phone and email, and may be required to execute and return an affidavit of eligibility, a liability release and, where lawful, a publicity release within seven (7) days of date of issuance. If such documents are not returned within the specified time period, a prize or prize notification is returned as undeliverable, Sponsor is unable to contact a potential winner or a potential winner is not in compliance with these Official Rules, prize will be forfeited and, at Sponsor's discretion, an alternate winner selected.
